Lange, F.E. born Oct. 16, 1825in Germany. He learned the trade of water making. Came to America in 1852 to Washington, D.C. In July he came to St. Peter, Minn. There he began Operating a jewelry and watch shop. He served as Mayor and Counvilman for several years.

Lange, William, born in 1830 in Germany. After his schooling, he learned the book-binding. Came to America in 1854 to Chicago. One year later he came to Belgrade, Nicollet County. Clained a piece of land, but sold it the next year and bought the present farm of 425 acres. Marrie in 1853 to Mary Hafer and had 2 children; Charles and Fred.

Nagel, Philip, born in 1822 in Germany. Came to America at the age of 30 years and spent 2 years in Iowa, then to Minn. He resided in Henderson for 1 year, then to Jessenland for 12 years, and now is living in Arlington Township. They had 11 children of whom only 4 are living; Charles, Martin, William and Henry.

Maertz, Joseph, born in 1852 in Bavaria, Germany. Came to America with his parents in 1855 and located on a farm at New Prague, Minn. for 3 years, he received his schooling there and then moved to St. Paul working in a shoe store for 5 years. He then remained at home with his parents for 2 years, then started his present general store in New Prague. Married in 1875 to Rosa Simota of this place. Their 2 children are; Mary and Joseph.

Maurer, William, born in 1824 in Germany. Learning the blacksmith trade for 3 years, then traveled for 2 years, served 6 years in the German army. Came to America in 1855 to Chicago. One year later came to Henderson, Sibley County, Minn. and claimed 160 acres in Dryden Township. In 1858 he went amoung the Indians to Yellow Medicine and remained 3 years. In 1862 he helped to raise a Company to serve against the Indians. Enlisted in Company H. 7th Minn. Inf. He held many Township offices in Dryden, also County Commissioner, Register of Deedsand now is the Clerk for the Borough of Henderson. Married in 1856 to Miss Wilhelmins and have 5 children.

Noe, John C. born May 2, 1844 at Newburg, New York. Receiving his early education there, and in 1866 was admitted to the bar at Pougkeepsie and practiced law there until 1873 when he came to Mankato, Minn: In October 1873 he was admitted to the courts of Minnesota. Married in 1868 to Anna Chandler of Fiskhill, New York.

Richter, Andrew, born in 1856 in Germany. Came to America in 1876 to Mankato, Minn. and engaged in the saloon business. Married in 1877 to Mary Stiener. Their children are; Annie C. and Mary.

Richter, A.J. born in 1856 in Austria. Came to America in 1869 to New Ulm, Minn. where he attended school. He worked in a brewery here for 4 years and also worked in a brewery at Mankato for 4 years: Since 1879 he operated a saloon here.

Maertz, John, born Mar. 5, 1841 at Darmstadt, Herzogtum in the grand duchy of Hessen Germany. He emmigrated to America in the early 1840's and lived with his uncle at Baltimore, Maryland. A few years later his uncle's house was destroyed by fire in which he lost his entire possession and also no place to make his home. This predicament prompted his direct cause for an immediate enlistment in the U.S. Armed Service. He was stationed at Fort Henry. Maryland. When the Mexican war broke out, his Regiment left for 'Mexico. Since Mr. Maertz had already been promoted to a Sergeant and detailed to drill recruits has remained at Fort Henry for that purpose. In 1847, he was transferred to Fort Snelling, Minnesota. Here he learned to speak the Sioux language quite fluently and became a great friend of one of the leading Chiefs of that tribe. One of these Chiefs insisted him to merry his daughter. Mr. Maertz has often mentioned this incident with great merriment later to his friends. At one time, his Company was ordered to the northwest, to Big Stone Lake where they encountered many hardships. Their rations consisted of a small quantity of coffe and flour. The flour was mixed with water and baked before the fire on chips cut from cottonwood trees. In 1849, his term in the Armed Service expired and was discharged, and immediately pre-empted an 80 acre homestead on what is now a part of St. Paul. In 1850, he sold it at a trifle price, but was enough to buy a co-partnership in the brewing business with Anton Yoerk which he subsequently sold to his partner. In 1852, he pre-empted an 80 acre homestead claim consisting of the East half of the Southeast quarter of Section 4, Township 115; Range 23, one mile east of Chaska.

The surrounding prairie like land bordering the Minnesota River inspired him to form a colony. In 1853, he laid out lots and platted a Townsite, naming the embryo future city "Yorkville" and was sure that it would soon become the great city of the Minnesota Valley. In that same year, Mr. Maertz established a store on the Townsite and employed the service of a likely young German immigrant by the name of Mr. Mons, who died shortly afterwards, being the first known white person to die in Carver County. In 1856, a Mr. Philip Henk built and operated a blacksmith shop near the store. Since the boat landing was at this point in those days, flat-boats transported suplies to this Townsite were placed in small rowboats which were then towed upstream This little Village continued to thrive until Chaska to the store. loomed up and wrestet the laurels from fair Yorkville which now exists only in name, especially to the older people of Chaska. Nevertheless, during all those long years, Mr. Maertz has remained active in the leadership of Yorkville, and like many other old settlers died comparatively poor in this world of plenty, but honored and respected by the entire community. Mr. Maertz was also known as John Mann by some of the older people. This came about because it was very difficulty for the Indians to pronounce the word of Maertz. Mr. Maertz married a second time, to the widow of the late Carl F. Elke, nee Louise W. Wolff and had 2 sons; Henry and John. They also reared a foster daughter, Mrs. C.C. Crandell of Edmeston, New York. Mr. Maertz died Jan. 22, 1900 at the home of his son, Henry at Glenwood City, Wisconsin and buried in Mt. Pleasant Cemetery at Chaska, Minnesota.

Habel, Benjamin, son of Joseph and Catherine Habel, born in 1823 in Neustadt, Upper-Silesia, Germany. In his youth he learned the cabinet maker trade. Married to Theresia Pfeffer and had 2 children, a daughter Anna Maria and a son Theodore. In 1850, Mr. Habel came to America, leaving his wife and children in Germany with the intention of first establishing a home here and later sending for his family. In 1851 he was employed on a flat-boat on the Minnesota River between St. Paul and On December 9, 1856 he pre-empted 120 acres of land in then Section 34 east of Chaska. He was a charter member of the so-called "Town of Yorkville" which was laid out in 1856 about a year before the present City of Chaska was established. On Dec. 10, 1856, he sold 80 acres of his claim to Henry Eschley for \$100, and planed to built a home on the remaining 40 acres. However, in the meantime he became ill and made his home with his sister and brother-in-law Mr. and Mrs. William Glatzel. He died on March 15, 1869 and was buried near the home of the Glatzel Homestead located on the Chanhassen-Chaska Township line. building of a new road in 1972 made it necessary to remove the grave; according to state statute. Disinterment of the 103-year old grave took place on August 17, 1972 under the supervision of State Officials and Edward A. Glatzel, grand-nephew and Walter J. Glatzel, great grandnephew of the deceased. Mr. Edward A. Glatzel, Chaskass 74-year old historian; literally pinpointed the unmarked gravesite. Under the auspices of the City of Chaska and the supervision of Edward A. Glatzel he was reburied on the same day in the extreme south east corner in the Guardian Angel's Chatolic Cemetery.

Mr. Habel's heirs sold 3 acres to the M. & St/L. railroad on June 8, 1872 for \$75. They also sold the remaining 36 acres to Michael Noll on Jan. 31, 1877 for \$100. This money was sent to his wife, Theresia nee Pfeffer, daughter, Anna Elizabeth and son Theodore in Germany.
